

## **2019 Consignment Agreement**

### **Consignment Agreement**

1. Congratulations on partnering with The Savvy Bride Boutique L.L.C. in helping to fulfill another bride's dream!
2. The undersigned ("Consignor") is the sole owner of all goods (the "Goods") consigned to The Savvy Bride Boutique L.L.C. ("SB") and has the legal right to enter into this Consignment Agreement (this "Agreement"); and the Goods are saleable and free & clear of liens, encumbrances, or other claims.
3. SB will be the exclusive seller and agent for sale of the Goods, and will retain its portion of the proceeds upon sale, as described herein.
4. SB retains the right to accept or decline any item for consignment at its sole discretion and retains the right to display items for sale as it sees fit.
5. Consignor agrees to present the Goods recently cleaned and in saleable condition free of defects.
6. Consignor will wait on site for SB staff to perform the initial screening of any offered Goods prior to SB's acceptance of any Goods to be consigned under this Agreement. The selling price (the "Price") of Goods will be determined by SB upon acceptance of Goods.
7. Goods will remain on-site at SB for one (1) year from the date of acceptance by SB (the "Consignment Period"). Goods will not be returned to Consignor until the expiration of the Consignment Period. The Price of Goods not sold after the first nine (9) months of the Consignment period will be reduced by 20%. Goods not sold by the expiration of the Consignment Period will be returned to the Consignor in sellable condition, less ordinary and customary wear from being offered for sale during the Consignment Period.
8. We at SB understand how much your dress meant to you on your special day and will do everything we can to ensure it is well protected and maintained while in our care; however, dresses will be tried on by customers throughout the consignment period and may experience standard wear as a result.
9. All Goods unclaimed after 30 days following the expiration of the Consignment Period will become the sole and exclusive property of SB. Consignor is responsible for claiming unsold Goods during SB's business hours within 30 days of expiration of the Consignment Period.
10. Consignor will be notified promptly when Goods are sold. Consignor will receive 50% of the proceeds from the sale, which will be mailed to the address on file. Savvy Bride has the right to discount list price 10% as a sales close discount.
11. SB makes no warranties, promises, or assurances except as expressly described herein, and in any case expressly does not guarantee any Goods will sell, or the time in which any Goods will sell, whether expressed or implied.
12. SB may change these consignment terms during the course of the Consignment Period as necessary. Consignor will be notified of any substantial change to the terms of this Agreement, and upon such notice, may choose to terminate this Agreement and promptly retrieve any Goods on site at SB during its normal business hours.
13. SB shall not be responsible for loss or damage to Goods due to fire, theft, vandalism, breakage or natural disaster.
